



### TIPS FOR TALKING TO CUSTOMERS

#### **Proof of vaccination status**

#### THE RULE

All customers and visitors to the premises aged 18 years and over need to provide proof of vaccination status before entry.

4 Easy Ways you can gain entry:

- There are four ways you can show proof of COVID-19 vaccination to gain entry to businesses and venues in Victoria.
- COVID-19 digital certificate via the Service Victoria app
- COVID-19 digital certificate saved to a smartphone wallet
- Printed copy of COVID-19 digital certificate
- Printed copy of immunisation history statement

- Contact Medicare or myGov by calling 132 307 Mon–Fri: 7am–10pm, Sat & Sun: 10am–5pm.
- For help to access your COVID-19 Digital Certificate or Immunisation History Statement, phone 1800 653 809 Mon-Fri between 8am and 5pm.
- If you do not have a smartphone, the Australian Immunisation Register can issue you with a printed copy of your certificate. You can also download and print a copy of your COVID-19 vaccination certificate or immunisation history statement from myGov.


Every business must have an updated COVIDSafe Plan. Get your plan today from coronavirus.vic.gov.au/plan.
